1. Part I. Applicant's Statement, must be completed in full.
2. Part II. Mother Advisor's and Board's Statement, must be completed in full.
3. Application Information must be signed below and returned with package.
4. More than one girl per assembly may apply.
5. Scholarships will only be available for accredited schools. No schools outside Oregon will be considered for the Oregon Grand Assembly Scholarship, the Hazel Graham or Steve Nacheff Scholarships. However, the Out of State and Verna Gray Scholarships are available for schools outside Oregon.
6. Only **FULLY COMPLETED** application forms will be considered – please read instructions carefully.
7. Scholarships from other sources will not exclude the student.
8. All forms must be signed by all applicable parties – please check carefully.
9. Applicants are typically entering their Freshman year, Fall or Winter Term while an active, paid current Rainbow Girl. Any college who does not register a girl for Fall or Winter Term will be instructed to send the money back to Grand Assembly. If she does not attend college for which she received a scholarship (and subsequently has forfeited), or if she was disqualified for some reason and is still an active, paid current Rainbow girl who has not attained majority next year, she may reapply if she will be re-entering or continuing college. However, a girl may not receive/use more than one of each of the scholarships listed in #5.
10. All applications must be postmarked, with all accompanying documentation, by April 15th. **Applications not postmarked on or before April 15th will be disqualified.** There will be no exceptions. Applications are to be mailed to:
